

Waiver and Release Form

I understand that dog training may involve risks to myself, members of my family, or my dog. I assume all risks associated with participating in this training class and will not hold Do Over Dog Training or its instructors responsible in the event of injury to myself, family members or my dog. I agree to comply with the instructions, rules and decisions of the training instructor as it relates to me or my dog's ability to safely complete this course. I also agree to assume all responsibility for any damage done to property, persons, or other dogs done by me or my dog's actions.

I understand that there will be no refund of tuition after the first class meeting. I also understand that there are no regularly scheduled make up sessions. If the Instructor deems my dog inappropriate for a class setting, tuition will be put towards a private lesson. If I plan on missing more than one class per session, I will have the option to make up one class if completed within 30 days. If classes are unable take place due to a government shutdown, unattended classes will not be refunded. Students will have the option of completing the session via virtual classes. I understand if I choose not to attend virtual classes, tuition will be forfeited.

I understand that I must not attend class if I am not feeling well or anyone in my family has been ill. I will not attend class for at least 14 days after travelling out of the country.

I understand that all dogs participating in the training classes at Do Over Dog Training must be free of any infectious disease and must be current on all appropriate vaccinations. I also understand that all dogs enrolled in the training course must be parasite free.

I understand that Do Over Dog Training does not guarantee the results of its canine training classes. Because of variables in dog breeding and temperament and owner commitment and experience, a trainer cannot and should not guarantee the results of his/her training.

I grant permission to Do Over Dog Training/Lori Timberlake, the irrevocable right to use my photograph(s), likeness and voice, including via video, and those of my dog(s) and of any minor children of mine who may have been photographed or recorded, for the following:

- Instructional purposes solely with me, members of my family or household, or other persons who regularly handle my dog, such as other dog care professionals hired by me, or other service professionals hired by me (such as nannies, housekeepers, and the like).
- Instructional purposes for other clients or students of Do Over Dog Training/Lori Timberlake, including one-on-one sessions, group classes, web seminars, in-person presentations, etc.
- Marketing purposes for Do Over Dog Training/Lori Timberlake such as but not limited to use on Do Over Dog Training's website, social media channels, webinars, in-person presentations, email newsletters, and print materials. I hereby release Do Over Dog Training and its legal representatives and assigns from all claims and liability relating to said photograph(s), video(s), likeness and voice.

Do Over Dog Training will endeavor to create as safe an environment as possible for the training of my dog and will offer only sound, safe, and responsible training and training instructions. However, to the



extent that Do Over Dog Training is insured for any unintentional or negligent errors, omissions, or incorrect assertions, Do Over Dog Training will be responsible for any such acts or omissions, but only to the extent of such insurance. I have been told by Do Over Dog Training and understand the inherent risks of owning a dog, including but not limited to the risk of dog bites to myself or others, and consequently I am and will remain responsible for the actions of my dog at all times, and I hereby agree to indemnify, release, and hold harmless Do Over Dog Training of any and all claims, whether made by myself or any third party. of injury, expense, costs, or damages caused by my dog.

I understand that the recommendation of any other product or service is not a guarantee of my satisfaction with that product or service.

I hereby agree to abide by the rules and policies of Do Over Dog Training's training classes as set forth in this contract. I understand that attendance of dog training classes is not without risk to myself, members of my family, guests who may attend, or to my dog. In consideration of, and as inducement to the acceptance of my application for training membership in this training class, I hereby agree to indemnify, release, and hold harmless Do Over Dog Training, its officers, directors, instructors, agents, employees and/or representatives of any and all claims made by myself or any member of my family, or accompanying guests of mine, or any other third party, of injury, expense, costs or damages to myself, my dog or any handler sponsored by me both in class and out of class. In addition, I agree that I will defend and indemnify Do Over Dog Training for any injury, expense, costs or damages to any dog handlers or dogs, whether sponsored by me or not, or to third parties arising out of my own actions or the actions of my dog.

This contract, together with language expressly incorporated into it in writing, is the full and complete agreement between me and Do Over Dog Training. A complete and accurate copy of this contract is as valid as the original. This contract is made valid by in-person signatures, electronically signed signatures, or upon receipt of a signed, scanned copy by email.
